Tove Engvall has Master in Archives and Information Science, which she teaches and conducts research in at the Mid Sweden University. Before this, Tove worked as an archivist, and has been involved in national projects concerning the development of e-archives. She was a project group member in the SALAR (Swedish Association of Local Authorities and Regions) framework procurement project. She worked as the leading writer in the group developing guidelines for users in the E-archive and E-diarium (eARD) project, run by the National Archives of Sweden as part of the National e-Government development. Tove's research interests involve issues concerning trust and accessibility of records in the wider digital environment.

Per Nymand-Andersen is an adviser to Senior Management in Directorate General Statistics at the European Central Bank. Per has developed his expertise in financial markets, securities settlement systems, statistics, big data and communication. Per is the key editor of the ECB's Statistics Working Paper Series and a lecture at the Goethe University in Frankfurt am Main;

Per has an MBA in Economics and Management Science from Copenhagen Business School, Denmark. Prior to joining the ECB, he provided market research consultancy services for Eurostat, Luxembourg. Per is author of several articles and publications regarding financial markets, statistics and communication.

Mario Pisani is Deputy Director at HM Treasury and a Senior Visiting Research Fellow at The Policy Institute at King's College London. Since joining HM Treasury in 2005, Mario has worked on international finance, communications, economic forecasting and macroeconomic policy. During 2015 and 2016 he led the team supporting Sir Charlie Bean's Independent Review of Economic Statistics ("the Bean Review"). During 2014 Mario joined the private office of the Chief Secretary to the Treasury, to support work on the Referendum on Scottish Independence. Between 2013 and 2016 he represented HM Treasury at the G20 Framework Working Group. Between 2008 and 2011 he was Private Secretary to the Chancellor of the Exchequer: first for Alistair Darling during the financial crisis and then later for George Osborne during the early years of the coalition government. During 2006, he was seconded to the Financial Times in London, where he worked as a leader writer having won a Nico Colchester Fellowship.

Jan Booth is Deputy Director at the Department of the Environment, Food and Rural Affairs (Defra). Jan is one of the foremost Knowledge and Information Management (KIM) professionals in UK government with over twenty years' experience of working with archives, data and organisational knowledge. His experience takes in local government, higher education, the health care sector, an international charity and in UK national government – first at HM Treasury and now at Defra. During three years at HM Treasury Jan was responsible for increasing access to the department's world-class archives, including the Private Office records of the Chancellor of the Exchequer. He led innovative work to better exploit historical sources and knowledge within the organisation whilst refreshing the KIM IT platform and raising KIM awareness and performance. Jan is a member of the UK Government KIM Leaders' Group and is a regular speaker at KIM and archives events.

Angelo Riva is private professor of finance at the European Business School, where he is dean of research. He is also an affiliate professor at the Paris School of Economics. He is the European coordinator of the H2020 Infrastructure Development project EURHISFIRM. He is the scientific manager of the 'Data for Financial History' project and the principal investigator of the projects 'Systemic risk in the 19030s' and 'Parisian Financiers' Belle Epoque (1871 – 1913): Space, Organisations and Social Structure'. His research focuses on European monetary and financial history. He has published in the Journal of Monetary Economics, the Economic History Review and Explorations in Economic History, among others.

Djordje Hinic has been with Piql since the end of 2015. Though he has initially been in charge of managing R&D projects, soon after he assumed the responsibility for business development and strategy. Currently, Djordje is managing Piql's operations in several European and Asian countries. Prior to joining Piql, Djordje was a consultant to US senator Tim Kaine and several other political and business executives across Europe, Africa, Asia and North America, and has taught at Westerdals College in Oslo.

Kertész Ákos is a professional with grade in IT engineering and programming has been in charge of informatics, CISO or IT auditor since 1997 at several Hungarian and international financial institutions (K&H Bank – KBC Group, MKB Bank, ING Bank, CIB Bank - Intesa Saopalo Group, Raiffeisen Bank, Sberbank). From 2011 onwards he served as an IT consultant on the service provider's side, supporting several international auditing firms. He is currently the senior supervisor of the MNB (Hungarian Financial Supervisory Authority), but he participated in the work of the Banking Security Working Group of the Hungarian Banking Association and as an IT expert in the information security audits of the State Audit Office of Hungary. Ákos has been a member of ISACA since 1999, has CISA and CISM certification.

Fergal O'Connor is Associate Professor of Finance in the University of York, and has previously lectured in York St. John University and University College Cork. He holds a PhD in Finance from the Trinity College Dublin which was funded by the London Bullion Market association. Prior to becoming a lecturer Fergal worked as a research fellow in University College Cork on a number of business projects and a project with Department of Trade Enterprise and Investment, Northern Ireland researching Productivity and Innovation in Small Open Economies. His research focuses on the operation of the precious metals market as well as its history.

Anton Comanescu is Economist at National Bank of Romania and Lecturer at Vrije Universiteit Brussel. Since his graduation in Economics from the Academy of Economic Sciences in Bucharest, he worked in the sphere of central banking and public sector finance, with ramifications to competition policy and EU affairs. Anton worked five years with DG MARKT and DG COMP in Brussels. In 2009 he joined the National Bank of Romania and dealt with the IMF financial assistance program for Romania. From 2013 on, as a Financial attaché in Brussels, he was engaged in negotiations within the Council of the European Union, on Banking Union files and, in general, on banking and financial sector reforms. The single supervision mechanism, bank recovery and resolution, deposit guarantee schemes, payment systems and money laundering are some of the building blocks he was focused on, in the framework of the new European financial architecture. Since 2017 he is working on financial education at the National Bank of Romania.

Michael Moss is professor of archival studies at Northumbria University and previously held the same post at the University of Glasgow. He has written widely on the financial services sector, including on savings banks, life assurance and most recently on the United Kingdom First World War savings campaign. He has contributed extensively to the literature on the transition from paper records to the digital. He is a member of the History Lab at Columbia University, which is pioneering computational techniques for exploring large corpora of digital records, such as those from the Enron Corporation.

Hrvoje Stančić is associate professor and Chair of Archival and Documentation Sciences at the Department of Information and Communication Sciences, Faculty of Humanities and Social Sciences, University of Zagreb. His research interests are long term preservation of digital archival materials, preservation of authenticity and trust in digital records, blockchain as well as digitisation. He is member of the Centre for International Study of Contemporary Records and Archives (CISCRA, Canada), Vice President of Croatian Archival Society, Faculty representative at the International Centre for Archival Research (ICARUS), and member of the Croatian Information Documentation Society. He is a Director of the European research team at the InterPARES Trust international research project and a President of the Croatian mirror committee of ISO/TC 307 – Blockchain and distributed ledger technologies.
