BGK was founded in 1924 by a decree of the President of the Republic of Poland as part of Prime Minister Władysław Grabski's plan for the recovery of the state treasury. It was created by the merger of three public banks from Galicia (a region under Austro-Hungarian authority) – the Polish Domestic Bank, the State Reconstruction Bank, and the Credit Institution of Malopolska Cities.
