
**CONFERENCE ‘MONETARY UNIONS IN HISTORY’
ARCHIVAL WORKSHOP ‘DIGITAL REBIRTH OF HISTORICAL DATASETS’
INFORMATION ON PROCESSING OF PARTICIPANTS’ PERSONAL DATA**

Българска народна банка/Bulgarian National Bank (BNB) is a personal data controller under Regulation (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) – GDPR. As a data controller, the Bulgarian National Bank processes personal data for purposes and reasons consistent with the requirements of the GDPR and the Law on Personal Data Protection.

The Bulgarian National Bank shall host the following events:

1. Conference ‘Monetary Unions in History’ (hereafter the ‘Conference’), jointly organized by the Bulgarian National Bank and the European Association for Banking and Financial History (*eabh*) e.V., to be held in Sofia on 1 July 2022; and
2. ‘Digital rebirth of historical datasets’, Archival Workshop (hereafter the ‘Workshop’), jointly organized by the Bulgarian National Bank and the European Association for Banking and Financial History (*eabh*) e.V., to be held in Sofia on 30 June 2022.

Filling in and sending the registration form for participation in the Conference/Workshop you declare your willingness to participate in the relevant event.

The BNB shall process personal data of the Conference/Workshop participants (the ‘participants’) under Art. 6, par. 1, (f) of General Regulation on Data Protection, namely – legitimate interest of the controller as processing your personal data is a necessary requirement to enable your participation. The BNB shall process your personal data only for the purposes of your participation in the Conference/Workshop and for promotion of the Conference/Workshop.

The following details: names, address, position, institution/organization/university shall be processed by the BNB for the Conference/Workshop management purposes.

The following details: names, position, institution/organization/university, photographs, audio and/or video material of the Conference/Workshop and the related events may be published on the BNB website, in a special BNB publication and/or in other Conference/Workshop promotional materials. If a participant is a co-author of a written material presented to the Conference/Workshop or is a Conference/Workshop moderator/panellist the following details provided to the BNB by the participant: e-mail address, details of academic and professional

activity (employer, position, university and specialty) or short biography, may be published on the BNB website, in a BNB publication or other promotional material.

During the Conference/Workshop and the related events photographs shall be taken, and video and audio shall be recorded by the BNB staff or other persons commissioned by the BNB. The participants may feature on these photographs, video or audio records.

The BNB informs the affected parties that the pictures, the video and the audio recording, taken at the Conference/Workshop or the related events, can be viewed or listened to by sending a request to e-mail: Conferences@bnbank.org .

Your personal data is processed only by BNB employees, whose duties or tasks require access to the data. The BNB employees are not allowed to process the personal data for purposes other than those specified in this information. The data may eventually be disclosed to state bodies with controlling powers in fulfillment of statutory obligations.

Personal data obtained in the course of the organization and hosting of the Conference/Workshop shall not be transferred to a third party. The European Association for Banking and Financial History (*eabh*) e.V. as a joint organizer of the Conference/Workshop has access to the personal data of the participant in its own legal basis.

The participants have the right to: access to, rectification and/or erasure of personal data and/or restriction of processing, as well as the right to data portability in compliance with the GDPR requirements.

The participants have the right to lodge a complaint with the Bulgarian Commission for Personal Data Protection (www.cpdp.bg) or with the competent Bulgarian Court under the Bulgarian Administrative Procedure Code.

The submission of the abovementioned personal data is a necessary requirement as the failure to provide data is an objective obstacle for participation in the Conference/Workshop.

The BNB does not carry out automated decision making, including profiling, in relation to the personal data provided for the purposes of the Conference/Workshop.

The BNB intends to store the participants' data for archive purposes.

The personal data are kept by the BNB within the time limits specified in the applicable legal acts or internal rules and procedures.

The BNB reserves the right to modify this Information unilaterally without prior notification.
